

## END-USER LICENSE AGREEMENT FOR ANALYZEDIRECT SOFTWARE: Analyze 14.0 and AVW 14.0

Important -- read carefully: This AnalyzeDirect end-user license agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and AnalyzeDirect, for the AnalyzeDirect software product identified above, which includes computer software and may include associated media, printed materials, and "online" or electronic documentation ("software product"). The software product may also include any supplements to the original software product provided to you by AnalyzeDirect. Any software provided along with the software product that is associated with a separate end-user license agreement is licensed to you under terms of that license agreement. By installing, copying, downloading, accessing or otherwise using the software product, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the software product. This EULA represents a sublicensing agreement granted to you by AnalyzeDirect, acting as a licensee of Mayo Foundation for Medical Education and Research ("MFMER"). MFMER is the developer and intellectual property owner of the software product. AnalyzeDirect is a licensee of MFMER, and can generate three types of sublicense for an end-user: a "node-locked license", a "dongle license" and a "floating license".

### SOFTWARE PRODUCT LICENSE

The software product, owned by MFMER, is protected by copyright laws, patent laws, trademark laws, international copyright treaties and other intellectual property laws and treaties. The software product is licensed, not sold.

#### 1. GRANT OF LICENSE

This EULA grants you the following rights:

"Node-locked license": You may install and use a single node-locked license copy of the software product on a single computer, including a workstation, terminal or other digital electronic device ("computer"). The node-locked license is locked to the MAC address of the computer. The computer on which the software product will be installed has been specifically identified in writing to AnalyzeDirect during the ordering process. If the software product is required to be used on other computers, additional node-locked license copies of the software product must be acquired for each other computer.

“Dongle license”: A dongle is a small USB device that allows Analyze to run when attached to a Windows-based computer. You may install and use a single fixed-node dongle license copy of the software product on a single computer, including a workstation, terminal or other digital electronic device ("computer"). The fixed-node dongle license is locked to the dongle (which will be supplied by AnalyzeDirect) attached to the computer. The computer on which the software product will be installed has been specifically identified in writing to AnalyzeDirect during the ordering process. If the software product is required to be accessed and used on other computers simultaneously, additional fixed-node dongle license copies of the software product must be acquired for each other computer, and a dongle will be supplied for each of these computers.

"Floating license": You may install the floating license manager from a floating license copy of the software product on a single computer, including a workstation, terminal or other digital electronic device ("floating license server"), and allow other computers within your company or institution to access and run the software product. The acquisition of a single floating license copy of the software product allows only one computer to access and run the software product at one time. If the software product is required to be accessed and run on other computers on the network simultaneously, additional floating license copies of the software product must be acquired.

“Subscription license”: You may use the Node-locked license, Dongle license or Floating license for a limited time, for example, one month, three months, twelve months etc. The choice of subscription licensing will be identified in writing to AnalyzeDirect during the ordering process.

“Perpetual license”: You may use the Node-locked license, Dongle license or Floating license for an indefinite time. The choice of perpetual licensing will be identified in writing to AnalyzeDirect during the ordering process.

“Rehosting”: The process of changing the computer on which a Node-locked or Floating license is installed is called Rehosting (this process does not apply to Dongle licenses, as the dongle can be used on any Windows-based computer). Perpetual Node-locked or Floating licenses are distributed in 12-month increments to allow users to change the computer on which the software product is installed during the renewal period (months 11 and 12 of the 12-month perpetual license increment). For perpetual licenses, no fees are charged to renew a license on the same computer. Additionally for perpetual licenses, no fees are charged to change the computer on which the software product is installed during the renewal period (months 11 and 12 of the 12-month perpetual license increment), but if the request is made during months 1-10 after the initial license installation or following the end of

the previous renewal period, a rehosting fee may apply. Rehosting is also available for subscription licenses, and no fees will be charged to change the computer on which the software product is installed at the end of the subscription period, although a rehosting fee may be charged if the request is made during the subscription period.

“Credit for payments made”: If a payment has been made for a perpetual license, and an initial long-term license file HAS NOT yet been transmitted either by email or by direct request from the Analyze License Manager to our FTP Server for retrieval, then a credit for future purchases can be requested and applied to your account. Credit for Payments made may NOT be requested if an initial long-term license file HAS been transmitted either by email or by direct request from the Analyze License Manager to our FTP Server for retrieval. If a payment has been made for a subscription license, and the subscription license file HAS NOT yet been transmitted either by email or by direct request from the Analyze License Manager to our FTP Server for retrieval, then a credit for future purchases can be requested and applied to your account. Credit for Payments made may NOT be requested if the subscription license file HAS been transmitted either by email or by direct request from the Analyze License Manager to our FTP Server for retrieval. Refunds for payments made for either perpetual or subscription licenses for which the license file HAS NOT yet been transmitted either by email or by direct request from the Analyze License Manager to our FTP Server for retrieval, are only considered under exceptional circumstances and on a case-by-case basis, and are not considered if the license file HAS already been transmitted.

## 2. OTHER RIGHTS AND LIMITATIONS

Field of use: The software product may only be used for research purposes in the field of biomedical imaging.

Rental, sale and sublicense: You may not rent, lease or lend the software product. You may not sell the software product. You may not sublicense the software product.

Modification: You may not modify, enhance, adapt, translate, create derivative works, reverse engineer, decompile, disassemble, or transfer the software product.

Intellectual property rights: This EULA does not grant you any rights in connection with any trademarks, copyrights, patent rights or any other intellectual property rights of AnalyzeDirect or MFMER.

### 3. WARRANTIES

Except as expressly provided herein, nothing in this EULA shall be construed as:

(a) A warranty or representation by AnalyzeDirect or MFMER as to the validity or scope of any copyrights or patents contained within the software product; or

(b) An obligation to bring or prosecute actions or suits against third parties for infringement;

(c) Conferring by implication, estoppel, or otherwise, any copyrights or patents of AnalyzeDirect or MFMER.

NOTWITHSTANDING ANY OTHER PROVISION IN THIS EULA TO THE CONTRARY, NEITHER ANALYZEDIRECT NOR MFMER HAS MADE AND MAKES NO WARRANTIES OF ANY NATURE, DIRECTLY OR INDIRECTLY, EXPRESS OR IMPLIED, REGARDING THE MERCHANTABILITY, NON-INFRINGEMENT, FITNESS FOR A PARTICULAR PURPOSE, SUITABILITY, DURABILITY, CONDITION, QUALITY OR ANY OTHER CHARACTERISTIC OF THE SOFTWARE PRODUCT. YOU AGREE TO TAKE THE SOFTWARE PRODUCT "AS IS" AND "WITH ALL FAULTS" AND HEREBY SPECIFICALLY WAIVE ALL RIGHTS TO MAKE ANY CLAIM AGAINST ANALYZEDIRECT OR MFMER FOR BREACH OF WARRANTY OF ANY KIND RELATED TO THE SOFTWARE PRODUCT.

LIMITATION OF LIABILITY: TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL ANALYZEDIRECT OR MFMER BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, CONSEQUENTIAL OR PUNITIVE DAMAGES WHATSOEVER, ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE PRODUCT OR THE FAILURE TO PROVIDE SUPPORT SERVICES, EVEN IF ANALYZEDIRECT OR MFMER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN ANY CASE, THE ENTIRE LIABILITY OF ANALYZEDIRECT AND/OR MFMER WHETHER JOINTLY OR SEVERALLY UNDER ANY PROVISION OF THIS EULA OR UNDER ANY LEGAL THEORY SHALL BE LIMITED TO THE AMOUNTS ACTUALLY PAID BY YOU FOR THE SOFTWARE PRODUCT.

This EULA is governed in all respects exclusively by the laws of the state of Minnesota, U.S.A., excluding its conflicts-of-law and choice-of-law provisions.

#### 4. ASSIGNABILITY

This EULA may be assigned, with notice to you in writing, to MFMER or MFMER's designee.

#### 5. USE FOR RESEARCH PURPOSES ONLY

You may only use the software product for research purposes. The United States Food and Drug Administration 510K approval has NOT been applied for nor received for use of the software product in a clinical setting.

#### 6. NAME USE

You agree not to use the name "AnalyzeDirect" for any public promotion, advertising or press releases without AnalyzeDirect's express, prior, written consent, which consent to AnalyzeDirect may withhold in its absolute discretion.

You agree not to use the name "Mayo" or "Mayo Clinic" for any public promotion, advertising or press releases without MFMER's express, prior, written consent, which consent to MFMER may withhold in its absolute discretion.
